Job Title: Certification Specialist (Dairy, Livestock & Field)

Summary Description: The Certification Specialist will coordinate the annual process of verifying the organic production practices of our dairy, livestock and field producers. Major duties include reviewing organic system plans and inspection reports, writing compliance letters and assisting farmers with the certification process.

Reports to: Certification Director

Responsibilities include:

- Review certification applications, inspection reports and supporting documentation and determine compliance status for processing and maple applicants assigned by supervisor
- Assign inspections for processing applicants and for maple applicants assigned by supervisor
- Provide information to persons requesting organic certification and respond to producer requests for information regarding their certification
- Serve as primary contact for processing applicants and with maple applicants assigned by supervisor
- Participate in VOF Staff meetings
- Support the development and maintenance of certification forms and documents including information materials to aid producers with NOP compliance
- Assist with Review Committee work and attend meetings
- Maintain an understanding of the USDA National Organic Program regulations, as well as VOF policy and procedures
- Implement certification policies and procedures
- Conduct inspections of operations requesting certification, as needed
- Organize and maintain certification files
- Work as a team to review brand name products for compliance with National List, update product review files and help to substantiate policy
- Track all outstanding adverse actions
- Work with Certification Director to respond to rebuttals and appeals of adverse certification decisions
- Assist with preparation for and attend Inspector Training
- Communicate with inspectors as far as appropriate workload and scheduling inspections
- Assist with preparation for and attend VOF Annual Meeting
- Assist with marketing of certified growers and VOF label in general
- Present certification information to producers and consumers when needed
- Work with technical assistance program to help producers get through certification process smoothly and identify areas of need
- Any other task relevant to these duties or the mission of the organization as assigned by supervisor

Qualifications
